Procedure for admission to study for foreign citizens (no visa entry to the Russian Federation)

step 1

PREPARE A PACKAGE OF NECESSARY DOCUMENTS:

- Authorized translation into Russian of a document on education and identity card or passport.
- Persons who have received education outside the territory of the Russian Federation must provide a certificate of recognition in the Russian Federation of their educational documents, if outside education does not fall within the scope of international agreements on mutual recognition. Recognition of outside documents on education on the territory of the Russian Federation is carried out in the Main State Expert Center for Educational Assessment (FGBU Glavekspertsentcentr https://nic.gov.ru)
- 4 photos, size 3 * 4
- Undergo a medical examination for people entering (specialty): 36.05.01 Veterinary medicine; 44.03.04 Vocational training (by industry); 35.03.06 Agroengineering; 23.03.03 Operation of transport-technological machines and complexes; 23.03.01 Technology of transport processes

Attention!

- Reception of documents for full-time education is carried out in the following period:
- from June 18 to July 11, 2020 to places of the federal budgeting
- from June 18 to August 20, 2020 to places under contracts on educational services

Submit documents to the admission committee

- Document on education and its authorized translation into Russian
- Identity card or passport and its authorized translation into Russian
- 4 photos, size 3 * 4
- Medical certificate for people entering (specialty): 36.05.01 Veterinary medicine; 44.04.04 Vocational training (by industry); 35.03.06 Agroengineering; 23.03.03 Operation of transport-technological machines and complexes; 23.03.01 Technology of transport processes

Entrance tests

Entrance exams, for full-time applicants for bachelor / specialty programs, are conducted in writing form in Russian language:

July 13 to July 27, 2020 - for federal budgeting

July 13 to August 20, 2020 - to places under contracts on educational services



Enrollment

Upon admission to full-time training, ORDERS for admission are issued in the following period: to the places under federal budgeting

-August 3, 2020 (stage 1) and August 8, 2020 (stage 2)

to places under contracts on educational services from July 29 to August 21, 2020
